- 1. Update on the dehumidifiers Jake is still looking for a dehumidifier that will fit at the Victory Plant
- 2. Schuylerville Plant roof has a water leak. Jake is going to get a quote from Bensons Roofing. Bensons found that the flashing/caulking around the vents had peeled away. This was repaired and the roof has stopped leaking.
- 3. Victory Plant had multiple shutdowns and Jake had to make several adjustments to a couple of valves that were not seating properly and the sensitivity of the new color monitor. The plant is running fine now.
